This includes overseeing educational technology, information technology infrastructure, security, data management, and support services. The Technology Manager will collaborate closely with school leadership, faculty, staff, students, and parents to ensure that technology effectively supports the school's mission and enhances teaching and learning. The Technology Manager reports to the Finance and Operations Director.
